NOTIFICATION

No. 410-F.T. – the 11th March, 2024 – Whereas, the demand of the local inhabitants for opening a new registration office at Lalgola in the district of Murshidabad was under active consideration of the government for sometime past;

Now, in exercise of the power conferred by sub-section (1) of Section 7 of the Registration Act, 1908 (16 of 1908), the Governor is pleased to establish the office of the Additional District Sub Registrar, Lalgola in the district of Murshidabad which will have its jurisdiction over Lalgola P.S.

The Governor is also pleased to create the following posts for smooth functioning of the newly created office of the Additional District Sub Registrar, Lalgola:
