The candidates have to produce certificate of qualification from any Madrassa, unless which, they have to produce a certificate of his possessing sufficient acquaintance with the Arabic language, and the Mohammadan law of marriage and divorce signed by three Mohammadan gentlemen of respectability and position and countersigned by the District Magistrate or District judge. Applications are required to be submitted in the prescribed pro-forma attached herewith along with certificate of good moral character issued by local M.P./ M.L.A./ B.D.O. along with age proof and residential proof. Applications are to be submitted at the office of the District Registrar, Jhargram on or before 26.02.2021 within office hours. Incomplete applications and applications received after due date will be rejected.


